

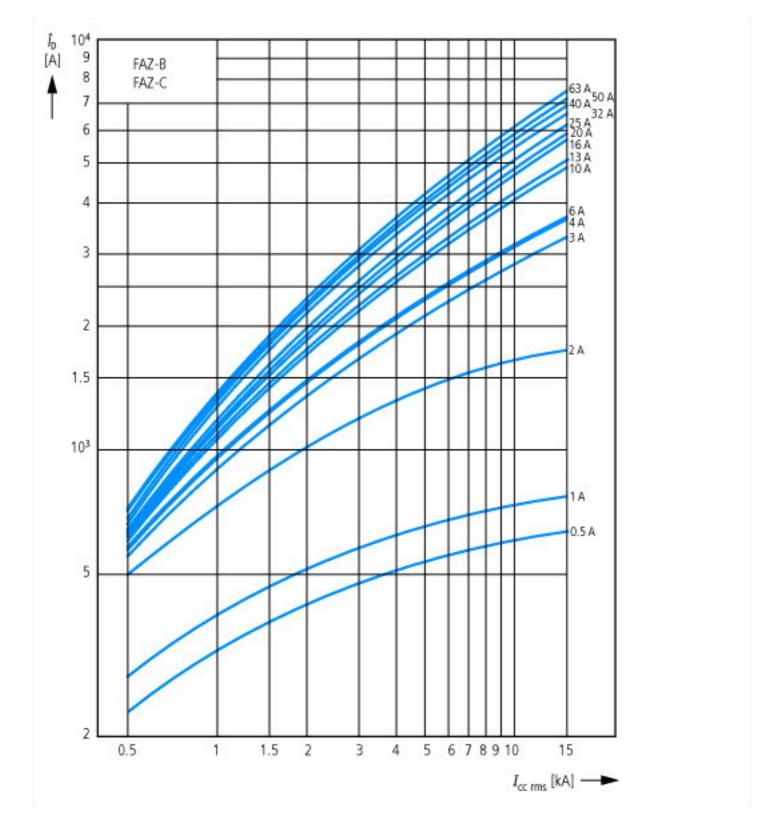




Let-through energy I<sup>2</sup>t According to IEC/EN 60898
